2. Policy Context

- From the week commencing 1 June 2020, the government is asking schools and colleges to plan to welcome back more children, as part of the response to coronavirus (COVID-19). See <u>Educational and childcare settings to prepare for wider opening from 1 June</u> for more details. The DfE has published <u>Implementing protective measures in education and childcare settings</u> to support this.
- Children will be able to return to early years settings, and Reception, Year 1 and Year 6 children will be back in school in smaller sizes, from this point. Secondary schools and colleges are expected to begin some face to face contact with Year 10 and 12 pupils.
- While the government does not expect all pupils to return to school at this stage, they have stated that special schools should work towards a phased return of more pupils and young people without a specific focus on year groups from 1st June. This is informed by the internal risk assessment process. Ifield School are gradually increasing the number of pupils in school, inviting more pupils back to school as and when it is safe to do so and endeavour to ensure that pupils and staff continue to maintain social distancing measures in place as numbers increase.
- The way Ifield School and King's Farm Primary School are currently operating in response to coronavirus continues to be different, however, as more children return, our safeguarding principles in accordance with '<u>Keeping Children Safe in Education</u>' (KCSIE) 2019, remain the same:
 - o the best interests of pupils will always come first
 - if anyone has a safeguarding concern about any pupil they should continue to act and act immediately
 - a DSL or deputy DSL is available
 - unsuitable people are not allowed to enter the children's workforce and/or gain access to children
 - o children should continue to be protected when they are online
- Any wider opening risk assessments (as set out in <u>action or education and childcare settings to</u> <u>prepare for wider opening from 1 June</u>) and related Health and Safety risk assessments will be appropriately linked into our safeguarding approach and safeguarding and child protection policy.
 - More information on health and safety and advice linked to coronavirus can be found in <u>managing school premises during the coronavirus outbreak</u> and coronavirus information and advice from <u>Health and Safety Executive</u>.
- This addendum of The Cedar Federation Safeguarding and Child Protection policy contains details of any amendments to our existing safeguarding arrangements and should be read alongside our current policies and procedures which can be found on the school websites:

- All staff and volunteers will be aware of the policy addendum and any revisions; the addendum will be made available publicly.

3. Designated Safeguarding Leads (DSLs)

- The DSL (or a deputy) will be available on-site. However, if in exceptional circumstances this is not be possible, a named DSL will be available to be contacted via phone or video call.
 - Should this not be possible Ifield School and King's Farm Primary School will share a DSL or deputy from the other school within the federation. DSLs named above will be available to be contacted via phone or video call. Ifield School contact telephone number: 01474 365485, King's Farm Primary School telephone number: 01474 566979.
- If a trained DSL (or deputy) is not on site, in addition to the above, a senior leader (Executive Headteacher, Head of School or Assistant Headteacher) will assume responsibility for co-ordinating safeguarding on site.
 - This will include updating safeguarding files and liaising with the offsite DSL (or deputy) and as required liaising with social workers where they require access to children and/or to carry out statutory assessments at the school.
- All staff and volunteers on-site will have access to a trained DSL (or deputy) and know on any given day who that person is, and how they can speak to them.
 - Up to date details of the DSL/Deputy DSLs will be visible to staff and children.
- The DSL/Deputy DSLs will continue to engage with social workers, and attend all multi-agency meetings, which can be done remotely.
- Ifield School and King's Farm Primary School will ensure that the DSLs (and deputies) have time to support staff and children regarding new concerns, and making referrals as appropriate, as more children return.

4. Vulnerable Children

- Vulnerable children in all year groups continue to be encouraged and expected to attend school where it is appropriate. (Further information can be found in the guidance on <u>vulnerable children</u> and young people)
- Vulnerable children for the purposes of continued attendance during the coronavirus outbreak are those across all year groups who:
 - are assessed as being in need under section 17 of the Children Act 1989, including children who have a child in need plan, a child protection plan or who are a looked-after child.
 - have an education, health and care (EHC) plan and it is determined, following risk assessment, their needs can be as safely or more safely met in school.
 - have been assessed as otherwise vulnerable and could therefore benefit from continued attendance. This might include children and young people on the edge of receiving support from children's social care services, adopted children, those at risk of becoming NEET ('not in employment, education or training'), those living in temporary accommodation, those who are young carers and others at the school/college and local authority's discretion.
- There is an expectation that children with a social worker will attend, unless in consultation with the child's social worker and family it is agreed they are at less risk at home or in their placement for example due to underlying health conditions.
- Where vulnerable children are not attending school, we will regularly keep in contact with them by telephone.
- Ifield School and King's Farm Primary School will encourage our vulnerable children and young people to attend a school, including remotely if needed. If it is not possible for a pupil to attend school regular contact and home learning will be maintained.
- In all circumstances where a vulnerable pupil does not take up their place at school, or discontinues, Ifield School or King's Farm Primary School will notify their social worker where applicable and follow up with the parent / carer.
- Ifield School and King's Farm Primary School will continue to work with professionals involved with children and share relevant information with them, such as social workers, early help workers and virtual school heads (VSH). This is especially important during the COVID-19 period.
 - This will include information about attendance and any welfare concerns.
 - If there is a safeguarding concern, this will be shared with the relevant professional as soon as possible.

5. Attendance

- From the 1st June, children in specified year groups and vulnerable children will be returning to school as agreed.
 - No one with symptoms should attend school for any reason.
 - Vulnerable children's attendance is expected, where there are no shielding concerns for the child or their household, and/or following a risk assessment for children with an EHC plan.
 - Parents and carers will not be penalised if their child does not attend educational provision whilst current Covid-19 restrictions are in place.

- For pupils agreed to be in school, we will resume our usual day-to-day attendance registers and processes in accordance with existing policies.
 - Full advice on children's attendance is available in '*Educational and childcare settings to prepare for wider opening from 1 June*'.
- Ifield School and King's Farm Primary School will continue to complete the <u>Educational Setting</u> <u>Status</u> form to keep a record which gives the DfE daily updates on how many pupils and staff are attending.
- Ifield School and King's Farm Primary School will:
 - continue to notify social workers where pupils with a social worker do not attend. Ifield School and King's Farm Primary School will also follow up directly with their parent/carer.
 - continue to follow up with any parent/carer whose child has been expected to attend and doesn't.
- Ifield School and King's Farm Primary School will ensure that regular contact is maintained with pupils (and their families) who are not yet returning to school.
 - With support from the DSL, teaching and/or pastoral staff are encouraged to make calls directly with pupils, where possible and appropriate.
 - Staff will make calls from the school/sixth form site and/or via school phones and devices.
 - If a school phone is not available or accessible, phone calls will be made from withheld numbers so personal contact details are not visible.
 - Staff will record the date, time and attendance of calls.
- To ensure contact can be maintained, Ifield School and King's Farm Primary School will confirm emergency contact numbers are correct with parents/carers and ask for any additional emergency contact numbers where they are available.

6. Reporting Concerns

- Where any concerns are raised about pupils or staff, Ifield School and King's Farm Primary School will follow existing and updated local arrangements as set out by <u>Kent Safeguarding</u> <u>Children Multi-Agency Partnership</u> (KSCMP) and as outlined in our existing safeguarding and child protection policy.
- Ifield School and King's Farm Primary School recognises that new safeguarding concerns may arise regarding individual children as we see them for the first time in person following partial school closures.
- All staff will continue to look out for any signs that indicate a child may be at risk, both on and off site, including online.
 - If a member of staff/volunteer has any safeguarding concerns about a pupil, this will be reported to the DSL as soon as possible.
 - If the concern is urgent, the member of staff/volunteer will speak to a DSL in person or via phone/video call if they are not on site, immediately.

- In the event a member of staff or volunteer cannot contact a DSL, this will not delay them taking immediate action to safeguard a pupil in line with our existing safeguarding and child protection policy.
- Concerns will be recorded using existing school safeguarding processes as outlined in our Safeguarding and Child Protection Policy.
- Prevent is a vital part of our work to safeguard children from radicalising influences; the school will continue to follow local processes where we have concerns during this challenging time. The DfE has published information for schools and colleges regarding <u>prevent management support</u> where learners are receiving Channel support.
- Pupils are encouraged to report concerns via existing school systems, or to a trusted adult at home.
- Parents/carers are encouraged to report concerns via existing school systems.
- Where staff are concerned about an adult working with pupils, they should report the concern to the Executive Headteacher or Head of School.
 - If there are concerns about any member of staff or volunteer, the LADO service will be consulted with.
 - Concerns around the Executive Headteacher should be directed to the Chair of Governors.
- Safeguarding concerns will continue to be recorded using existing school safeguarding processes as outlined in our Safeguarding and Child Protection Policy (yellow form at Ifield, green form at King's Farm).
- Staff are reminded of the need to report any concern immediately and without delay.

7. Movement of Pupils

- If pupils are attending another setting, the school will continue to do whatever they reasonably can to provide the receiving institution with any relevant welfare and child protection information, especially if children are vulnerable.
 - For looked-after children, any change in school will be led and managed by the virtual school head with responsibility for the child.
- The receiving institution will be aware of the reason any child is vulnerable and any arrangements in place to support them. This will take place ideally before a child arrives or as soon as reasonably practicable.
- Any exchanges of safeguarding information will take place between DSLs (or a deputy) and SEND information will be shared by special educational needs co-ordinators/named individual with oversight of special educational needs (SEN) provision for children with EHC plans.
 - o If this is not possible, the Head of School, will take responsibility.

• The school will continue to have appropriate regard to data protection law but is aware this does not prevent the sharing of information for the purposes of keeping children safe. Further advice about information sharing can be found at paragraphs 76 to 83 of <u>KCS/E</u>.

8. Safer Working Practice, Including Safeguarding Training and Induction

- All staff will follow our existing staff code of conduct/behaviour policy and any addendum updates with regards to safer working practice, both on and off site.
 - Staff will continue to follow any updates to the school code of conduct/behaviour policy which have been made to reflect current Covid-19 measures and increased numbers of pupils on site from 1st June.
 - School leaders/DSLs should be aware of the updated <u>Safer Working Practice</u> Guidance– policies may need to be amended to reflect new expectations and requirements in response to required and expected Covid-19 measures.
- All staff have read KCSIE 2019 Part 1 and accessed safeguarding training.
- Staff will be made aware if any local processes or arrangements have changed as more pupils return, so they know what to do if there are concerns about a child.
- Any new staff and volunteers will receive child protection induction training from the DSL and will be provided with a copy of the Federation Safeguarding and Child Protection Policy and Covid-19 Addendums.
- Staff may continue to move between school on a temporary basis; consideration will be given by the receiving school DSL as to what induction they need on a case by case basis, dependent on existing skills and knowledge. Transferring staff will always be given a copy of the receiving setting's child protection policy, confirmation of local processes and confirmation of DSL arrangements.
- Face to face DSL refresher training is unlikely to take place whilst there remains a threat of the Covid-19 virus. For the period Covid-19 measures are in place, a DSL (or deputy) who has been trained will continue to be classed as a trained DSL (or deputy), even if they miss their refresher training.
 - Formal DSL refresher training will be undertaken as soon as possible; the DSLs (and deputies) will continue to do what they reasonably can to keep up to date with safeguarding developments.

9. Safer Recruitment, volunteers and movement of staff

- It remains essential that people who are unsuitable are not allowed to enter the children's workforce or gain access to children.
- During the return to school period, if Ifield School or King's Farm Primary School recruit new staff, we will continue to follow the relevant safer recruitment practices including those set up in part 3 of KCSIE 2019.

- If volunteers are recruited Ifield School and King's Farm Primary School will continue to follow the guidance in accordance with KCSIE 2019 and with a mind to updates to the <u>Safer Working</u> <u>Practice Guidance</u> produced as a response to Covid-19.
 - Volunteers who have not had the relevant checks will not be left unsupervised with a child.
- If staff from other settings volunteer or begin working at Ifield School or King's Farm Primary School we will ensure they have a relevant DBS check following DfE guidance at this time. Ifield School and King's Farm Primary School will risk assess staff from other settings, as we would for a volunteer.
- If staff are deployed from another education or children's workforce setting to our school, we will consider the DfE supplementary guidance on safeguarding children during the COVID-19 pandemic and will accept portability if the current employer confirms in writing that:
 - the individual has been subject to an enhanced DBS and children's barred list check
 - there are no known concerns about the individual's suitability to work with children
 - there is no ongoing disciplinary investigation relating to that individual
- A new DBS check for returning staff who have continued to be employed but have not been working in regulated activity is not required, however, if for any reason the school have concerns about an individual, we may obtain a new check.
- In response to COVID-19, the Disclosure and Barring Service (DBS) has made changes to its guidance on <u>standard and enhanced DBS ID</u> checking to minimise the need for face-to-face contact. The Home Office and Immigration Enforcement have also temporarily adjusted the <u>Right</u> to work checks due to coronavirus (COVID-19).
 - Ifield School and King's Farm Primary School will continue to refer to the DBS anyone who has harmed or poses a risk of harm to a child in accordance with KCSIE 2019.
- Ifield School and King's Farm Primary School will continue to consider and make referrals to the Teaching Regulation Agency (TRA) where appropriate. During Covid-19 measures, all referrals will be made by emailing <u>Misconduct.teacher@education.gov.uk</u>.
- Ifield School and King's Farm Primary School will continue to update the single central record in line with KCSIE. (Paragraphs 148 to 156)
 - The SCR will provide the means to log everyone that will be working or volunteering in the school on any given day, including any staff who may be on loan from other institutions. The SCR will be used to log details of any risk assessments carried out on volunteers and staff on loan from elsewhere.

10. Supporting Wellbeing

 Ifield School and King's Farm Primary School recognises that staff, parents/carers and pupils may experience some degree of emotional wellbeing or anxiety challenges as more children return to school.

- Ifield School and King's Farm Primary School recognises that many children consider school to be a safe place and the current situation may impact on pupils', staff and parent/carers mental health.
- Ifield School and King's Farm Primary School will plan to ensure everyone feels supported through an inclusive culture and that everyone returns to a positive working environment to help relieve any anxiety or fear. The DfE guidance on <u>mental health and behaviour</u> in schools may help schools/colleges identify children who might need additional support, and to put this support in place.
- Ifield School and King's Farm Primary School will ensure the whole community are welcomed. Staff and learners and will be given the opportunity for wellbeing check ins within trusted relationships.
- Ifield School and King's Farm Primary School will ensure that all children who are categorised as vulnerable or children of critical workers, as well as those children returning to school from 1st June onwards, are appropriately supported.
 - Staff will address the wellbeing of pupils through a range of approaches including age/ability appropriate activities.
 - Pastoral staff will be available for pupils and will be given the time to provide support as required.
- Ifield School and King's Farm Primary School are conscious of the wellbeing of all staff and the need to implement flexible working practices in a way that supports staff and promotes good work-life balance.
 - Senior leaders and the DSL (or deputy) will be available to provide support to staff as required.
- Teachers will be aware of the impact the current circumstances can have on the mental health of pupils (and their parents) who are continuing to work from home, including when setting expectations of children's' work.
- Ifield School and King's Farm Primary School will continue to signpost staff, pupils and parents/carers, on or off site, to a range of appropriate sources of support, internally and externally.

11. Supporting Pupils in School

- Ifield School and King's Farm Primary School are committed to ensuring the safety and wellbeing of all pupils.
- King's Farm Primary School will be mindful of the specific needs of pupils in reception, year 1 and year 6 and all other pupils who have been identified as the first to return to school.
- Ifield School and King's Farm Primary School are aware that children of different ages with differing needs will be accepted as the weeks progress, so will keep under review the specific needs of all pupils.

- Ifield School and King's Farm Primary School need to be confident we have up to date information on pupils returning to site which reflects any changes in circumstances which could impact on their welfare.
 - Ifield School and King's Farm Primary School led by DSL or deputy, will do all we reasonably can to ask parents and carers to advise us of any changes regarding welfare, health and wellbeing that we should be aware of before a pupil returns to school.
- Ifield School and King's Farm Primary School will be safe spaces for all pupils to attend and flourish. A senior member of staff will ensure that there is an appropriate number of staff on site and that staff to pupil ratios have been considered to maximise the safety of pupils.
- Ifield School and King's Farm Primary School will follow the current government guidance in relation to social distancing and all matters relating to public health from the respective authorities. KCC '<u>Return to School'</u> Guidance provides additional information.
- Ifield School and King's Farm Primary School will continue to record any support provided to pupils in relation to safeguarding issues in line with our existing safeguarding recording system.

Peer on Peer Abuse

- Ifield School and King's Farm Primary School continues to recognise and respond to cases of peer on peer abuse by considering each incident on a case by case basis and basing any intervention on usual processes outlined within KCSIE 2019.
- Ifield School and King's Farm Primary School recognises that the current circumstances and the changeable nature of Government guidance may mean that the school needs to adapt elements of the process in some cases to ensure that they are able to respond in line with advice when required.
- Government guidance has recommended smaller class sizes, staggered lunch breaks, social distancing, and several adaptions to the school day that will require a range of strategies to help manage children's interactions with one another and their own understanding of what is appropriate behaviour at this time.
- The DSL will continue to consult as appropriate with multi-agency professionals to ensure that children's safety and wellbeing is not compromised when incidents of peer on peer abuse are brought to their attention.

Online safety

- Ifield School and King's Farm Primary School expectations with regards online behaviour and education when using school provided devices or internet access on site will continue to be implemented in line with existing polices.
 - Any concerns regarding onsite online behaviour or use will be responded to in line with existing policies.

- Ifield School and King's Farm Primary School will continue to provide a safe online learning environment where pupils use school provided devices on site; appropriate filtering and monitoring will continue to be implemented.
 - Pupils internet use will be supervised by staff according to their age and ability and pupils will be directed to use appropriate online resources and tools.
- Use of staff and pupil personal devices, including mobile phones, will be managed in line with our existing Online Safety Policy and Acceptable Use Policies.

12. Supporting pupils not in school

- The Government has strongly encouraged children in eligible year groups to return to school unless they are self-isolating or shielding, however there may be a significant number of children still not attending school.
 - Ifield School and King's Farm Primary School will continue to ensure the safety and wellbeing of all pupils and young people on the school roll but who may not be physically attending.
- All DSLs will continue to identify vulnerable children who would benefit from Early Help as identified in KCSIE 2019, provide pastoral support and consider whether they would benefit from external support.
- There will be clear plans around how best to communicate with pupils who are identified as vulnerable, as well as those whom DSLs have concerns about, who do not receive a statutory service.
 - \circ This could include telephone contact and/or doorstep visits at the discretion of the DSL.
- Ifield School and King's Farm Primary School and the DSL will work closely with all relevant agencies and professionals regarding safeguarding a pupil who has been identified as able to return but for whatever reason is not doing so.
 - Any plans will be reviewed regularly and if concerns become significant, the DSL will consider any requests for support if considered appropriate.
 - Where parents/carers opt to supplement the school remote learning offer, we emphasise the importance of securing online support from a reputable organisation/individual who can provide evidence that they are safe and can be trusted to have access to children.
 - The school will utilise its website to ensure that safeguarding messages are shared with pupils and their families. This will include links to appropriate services and resources that are aimed at supporting them throughout this period.

Online safety away from school

- All staff will continue to look out for any signs that indicate a child may be at risk online and will
 report and respond to concerns in line with the Safeguarding and Child Protection Policy
 addendum.
 - Where necessary, referrals will be made to LADO, children's social care and as required, the police.

- Pupils are encouraged to report concerns to a member of staff or a trusted adult at home. Where this is not possible, additional support can be accessed online via:
 - o Childline: <u>www.childline.org.uk</u>
 - o UK Safer Internet Centre's 'Report Harmful Content': <u>https://reportharmfulcontent.com</u>
 - National Crime Agency Child Exploitation and Online Protection Command (NCA-CEOP): www.ceop.police.uk/safety-centre
- Parents/carers will continue to be made aware of what their children are being asked to do
 online, including the sites they will be asked to access. Ifield School and King's Farm Primary
 School will continue to be clear who from the school (if anyone) their child is going to be
 interacting with online.
- Parents/carers will continue to be encouraged to ensure children are appropriately supervised online and that appropriate parent controls are implemented.
- Ifield School and King's Farm Primary School will ensure any sharing of information, communication and use of online learning tools and systems is in line with privacy and data protection/GDPR requirements.
- All communication with pupils and parents/carers will take place:
 - within school hours as much as possible. with staff using school devices over personal devices wherever possible and in line with our existing AUP. Where this is not possible, staff will speak with SLT.
 - using school provided or SLT approved communication channels; for example, school provided email accounts and phone numbers and/or agreed systems e.g. Google Classroom, Microsoft 365 or equivalent.
 - Any pre-existing relationships or situations which mean this cannot be complied with will be discussed with the DSL.
- Staff and pupils will engage with remote teaching and learning in line with existing behaviour principles as set out in our school behaviour policy/code of conduct.
- When delivering remote learning, staff will:
 - o only use online tools that have been evaluated and agreed by leadership.
 - o ensure remote learning activities are planned in accordance with our curriculum policies, taking pupil needs and technology access into account.
 - o record the length, time, date and attendance of any online lessons/contact held or made.
 - o revisit relevant policies such as our acceptable use of technology policy with pupils as necessary.
- Where remote learning is taking place 'live' for example using webcams or chat facilities, staff and pupils will ensure a safe and professional environment is maintained in line with our Remote Learning Acceptable Use Policy (AUP).
